

ORDINANCE NO. 9308

AN ORDINANCE OF THE CITY OF EL RENO, OKLAHOMA, AMENDING ARTICLE I OF CHAPTER THIRTY-FIVE (35) OF THE CODE OF ORDINANCES OF THE CITY OF EL RENO, OKLAHOMA, CONCERNING WARD DISTRICT BOUNDARIES; DECLARING REPEALER; PROVIDING FOR SEVERABILITY; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL RENO, OKLAHOMA:

SECTION 1: That Section 1 of Chapter 35 of The Code of Ordinances of the City of El Reno shall be amended to read as follows:

§ 35-1 Boundaries of Ward 1.

Beginning at the northwest corner of Block Seventeen (17) of the Lake View Addition of the City of El Reno, the same being the northwest corner of Ward 1, thence easterly 0.80 miles along Sunset Drive, thence easterly 0.38 miles along E Russell St, thence southerly 0.19 miles along S Roberts Ave, thence easterly 0.56 miles along E Watts St, thence southerly 0.50 miles along S Shepard Ave, thence westerly 0.94 miles along E Elm St, thence westerly 0.18 miles along W Elm St, thence southerly 0.27 miles along S Jensen Ave, thence westerly 0.32 miles along W Odell St, thence northerly 0.27 miles along S Reno Ave, thence westerly 0.31 miles along W Elm St, thence northerly 0.68 miles along S Boynton Ave to the point of beginning.

SECTION 2: That Section 2 of Chapter 35 of The Code of Ordinances of the City of El Reno shall be amended to read as follows:

§ 35-2 Boundaries of Ward 2.

Beginning at the intersection of N. Chiles Rd. and 164th St. NW, the same being the northwest corner of Ward 2, thence easterly 3.49 miles along the 164th St. NW right-of-way to the city limit boundary, thence southerly approximately 3.5 miles along the city limit boundary, thence westerly approximately 0.5 miles along the city limit boundary to N. Country Club Rd., thence southerly 1.51 miles along N Country Club Road, thence westerly 0.25 miles along Britton Road NW, thence southerly approximately 0.25 miles along the city limit boundary, thence east approximately 0.25 miles along the city limit boundary, thence southerly approximately 0.75 miles along the city limit boundary to W. Jones Rd., thence easterly 0.74 miles along W Jones Road, thence southeasterly approximately 0.25 miles along the city limit boundary, thence easterly approximately 0.32 miles along the city limit boundary to N. Choctaw Ave., thence southerly 0.12 miles along N Choctaw Ave, thence southeasterly 0.24 miles along the city limit boundary, thence northerly 2.28 miles along the city limit boundary to Hefner Rd NE, thence easterly 4.49 miles along Hefner Road NE, thence southerly 1.01 miles along N Manning Road, thence westerly 0.51 miles along Britton Road NE, thence southerly approximately 0.5 miles along the city limit boundary, thence easterly approximately 0.5 miles along the city limit boundary, thence southerly 0.50 miles along N Manning Road, thence easterly 0.21 miles along Wilshire Blvd NE, thence southerly 0.49 miles along N Manning Road, thence westerly approximately 0.25 miles along the city limit boundary, thence southerly approximately 0.5 miles along the city limit boundary to E. Foreman Rd., thence westerly 4.76 miles along E Foreman Road, thence southerly 0.31 miles along Choctaw Ave, thence westerly 0.74 miles along Sunset Drive, thence southerly 0.25 miles along S Boynton Ave, thence westerly 0.04 miles along W Blake St, thence northerly 0.03 miles along Fillmore Ave, thence westerly 0.21 miles along the alley running east and west through Blocks Two (2) and Three (3) of the Boynton Heights Addition to the City of El Reno, Oklahoma, thence westerly 0.14 miles along Palo Verde Drive, thence northerly 0.10 miles along Willow Creek Drive, thence westerly 0.25 miles along Parkview Drive, thence following Babcock Drive for approximately 0.29 miles to the intersection of Melone Drive, thence westerly 0.51 miles along Melone Drive, thence southwesterly 0.77 miles along Reformatory Rd, thence westerly 1.30 miles along Elm St W, thence

northwesterly 0.13 miles along I- 40, thence westerly approximately 0.13 miles along the city limit boundary, thence northerly 1.00 miles along the city limit boundary, thence westerly 0.44 miles along Sunset Drive, thence westerly 1.58 miles along Hwy 66 W, thence northerly 0.97 miles along S Fort Reno Road, thence westerly 0.24 miles along Jones Road NW, thence northerly 2.00 miles along N Fort Reno Road, thence easterly 1.99 miles along Darlington Road NW, thence northeasterly 1.38 miles along the city limit boundary, thence northerly along N Chiles Road to the point of beginning, LESS AND EXCEPT:

Beginning at the northwest corner of Tinsley's Addition to El Reno, being within the East Half of Section 13, Township 13 North, Range 8 W.I.M, Canadian County, Oklahoma, thence southerly 0.47 miles along the west line of said Addition, thence easterly 0.13 miles along the south line of said Addition, thence northerly 0.12 miles along the east line of Lots 23-25 of said Addition, thence easterly 0.15 miles along the south line of Lots 27-30 of said Addition, thence northerly 0.13 miles along N Reformatory Road, thence westerly 0.25 miles along the north line of Lots 1-6 of said Addition, thence northerly 0.25 miles along the east line of Lots 8-11 of said Addition, thence westerly 0.08 miles along the north line of said Addition to the point of beginning.

SECTION 3: That Section 35-3 of Chapter 35 of The Code of Ordinances of the City of El Reno shall be amended to read as follows:

§ 35-3 Boundaries of Ward 3.

Beginning at the intersection of E Wilshire Blvd. and N. Banner Rd., the same being the northeast corner of Ward 3, thence southerly 2.00 miles along N. Banner Rd., thence westerly 1.00 miles along Elm St E, thence southerly 1.53 miles along S Manning Road , thence westerly 1.61 miles along I-40, thence southwesterly 0.61 miles along the city limit boundary, thence westerly 0.16 miles along Jensen Road E, thence northerly 0.09 miles along S Radio Road, thence westerly 0.37 miles along the city limit boundary, thence northeasterly 0.47 miles along the city limit boundary, thence westerly 1.00 miles along I-40, thence southerly 2.53 miles along the city limit boundary, thence westerly 5.50 miles along OKC Reno St, thence northerly 1.00 miles along S Chiles Road, thence easterly 0.25 miles along W OKC 10th St., thence northerly 0.25 miles along the city limit boundary, thence westerly 0.25 miles along the city limit boundary, thence northerly 0.75 miles along S Chiles Road, thence easterly 3.00 miles along W Jensen Road, thence northerly 1.01 miles along S Country Club Road, thence easterly 0.14 miles along the south line of Section 17, Township 12 North, Range 7 W.I.M., thence easterly 0.52 miles along SW 27th St, thence northerly 0.32 miles along S Miles Ave, thence easterly 0.02 miles along SW 23rd St, thence northerly 0.05 miles along S Miles Ave, thence easterly 0.05 miles along Amity Lane, thence northerly 0.72 miles along S Jensen Ave, thence easterly 1.12 miles along Elm St, thence northerly 0.50 miles along S Shepard Ave, thence westerly 0.50 miles along E Watts St, thence southerly 0.01 miles along S Foster Ave, thence westerly 0.06 miles along E Watts St, thence northerly 0.19 miles along S Roberts Ave, thence westerly 0.44 miles along Russell St, thence northerly 0.31 miles along Choctaw Ave , thence easterly 3.23 miles along Foreman Road, thence southerly 0.25 miles along the city limit boundary, thence easterly 0.76 miles along the city limit boundary, thence southerly 0.03 miles along Evans Road, thence easterly 1.23 miles following the city limit boundary to S Manning Rd., thence northerly 1.50 miles along the Manning Road right-of-way, thence easterly 1.00 miles along Wilshire Blvd NE to the point of beginning.

SECTION 4: That Section 35-4 of Chapter 35 of The Code of Ordinances of the City of El Reno shall be amended to read as follows:

§ 35-4 Boundaries of Ward 4.

Beginning at the intersection of Babcock Drive and Parkview Drive, thence easterly 0.25 miles along Parkview Drive, thence southerly 0.10 miles along Willow Creek Drive, thence easterly 0.14 miles along Palo Verde Drive, thence easterly 0.21 miles along the alley running east and west through Blocks Two (2) and Three (3) of the Boynton Heights Addition to the City of El Reno, Oklahoma, thence southerly 0.03 miles along Fillmore Ave, thence easterly 0.04 miles along W Blake St, thence southerly 0.43 miles along S Boynton Ave, thence easterly 0.31 miles along W Elm St, thence southerly 0.27 miles along S Reno Ave, thence easterly 0.32 miles along W Odell St, thence southerly 0.45 miles along S Jensen Ave, thence westerly 0.05 miles along Amity Lane, thence southerly 0.05 miles along S Miles Ave, thence westerly 0.02 miles along SW 23rd St, thence southerly 0.32 miles along S Miles Ave, thence westerly 0.52 miles along SW 27th St, thence easterly 0.14 miles along the south line of Section 17, Township 12 North, Range 7 W.I.M., thence southerly 1.01 miles along S Country Club Road, thence westerly 2.00 miles along W Jensen Road, thence northerly 0.50 miles along S Airport Road, thence westerly 1.00 miles along the city limit boundary, thence northerly 1.44 miles along S Chiles Road, thence easterly 1.55 miles along W Elm St, thence northeasterly 0.77 miles along Reformatory Rd, thence easterly 0.51 miles along Melone Drive, thence northeasterly 0.29 miles along Babcock Drive to the point of beginning.

SECTION 5: That Sections 35-5 and 35-6 of Chapter 35 of The Code of Ordinances of the City of El Reno shall be repealed.

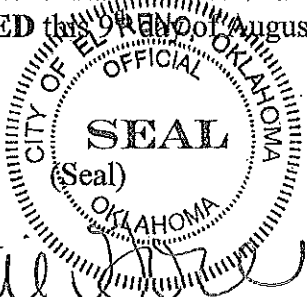
SECTION 6. All former Ordinances or parts of Ordinances conflicting or inconsistent with the provisions of this Ordinance are hereby repealed.

SECTION 7. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, said portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions of this Ordinance.

SECTION 8. It being immediately necessary for the preservation of the public health, peace, and safety of the City of El Reno and the inhabitants thereof, an emergency is hereby declared to exist by reason whereof, this Ordinance shall be in full force and effect from and after its passage and approval, as provided by law.
